**PROPOSED INTERVENORS' UNOPPOSED MOTION FOR
EXTENSION OF TIME TO FILE REPLY IN SUPPORT OF MOTION TO INTERVENE**

The American Hospital Association, 340B Health, America's Essential Hospitals, the Association of American Medical Colleges, National Association of Children's Hospitals d/b/a the Children's Hospital Association, and American Society of Health-System Pharmacists (collectively the Proposed Intervenors) hereby file this motion seeking a one-week/four-day extension, from March 12/15, 2021, to **March 19, 2021**, to file their reply in support of their motion to intervene. Both Plaintiffs and Defendants have consented to the extension.

On February 29, 2021, Proposed Intervenors filed a motion to intervene in this case. ECF No. 40. Plaintiffs' and Defendants' responses were due on Friday, March 5, 2021. According to that schedule, Proposed Intervenors reply would be due on March 12, 2021. On March 5, 2021, Plaintiffs filed a Conditional Opposition to the Motion to Intervene (ECF No. 70); and having missed that deadline, on March 8, 2021, Defendants filed a motion to file their Opposition to

Intervention *nunc pro tunc* (ECF No. 73). Accordingly, Proposed Intervenors' reply would be due on Monday, March 15, 2021.

Pursuant to local rule 6-1, Proposed Intervenors file this motion to extend their deadline to file a reply brief that addresses arguments in the Plaintiffs' and Defendants' respective oppositions, to **Friday, March 19, 2021**. The deadline for Proposed Intervenors has not previously been extended, and all parties consent to the extension requested herein. In addition, because Proposed Intervenors are not participating in the briefing on the current Motion for Preliminary Injunction, the requested extension will not interfere with the any related hearings or deadlines.
