**JOINT STATUS REPORT**

Pursuant to the Court’s order of September 12, 2024, ECF 65, the parties respectfully submit this Joint Status Report.

***TMA III and LifeNet III***

On August 24, 2023, the United States District Court for the Eastern District of Texas granted in part and denied in part the parties’ cross-motions for summary judgment in *Texas Medical Association v. U.S. Department of Health and Human Services*, No. 22-cv-450 (E.D. Tex.) (lead case) (“*TMA III*”), and *LifeNet, Inc. v. U.S. Department of Health and Human Services*, No. 22-cv-453 (E.D. Tex.) (“*LifeNet III*”). On October 30, 2024, the Fifth Circuit reversed portions of the district court’s ruling and affirmed others. *Tex. Med. Ass’n v. U.S. Dep’t of Health & Human Servs.*, 23-40605, 120 F.4th 494 (5th Cir. 2024). As relevant here, the Fifth Circuit upheld the portions of the rule that Plaintiffs challenge in this case. On December 16, 2024, Plaintiffs petitioned for rehearing *en banc*. On December 17, 2024, the Fifth Circuit withheld its mandate and requested a response to Plaintiffs’ petition. Defendants filed their response on January 17, 2025. On May 30, 2025, the Fifth Circuit granted re-hearing *en banc* and vacated its previous opinion. *See Tex. Med. Ass’n v. U.S. Dep’t of Health & Human Servs.*, 23-40605, Dkt. 177-1 (May 30, 2025). Appellants filed their supplemental *en banc* brief on July 21, 2025; Appellees’ filed their *en banc* brief on August 18, 2025; Appellants filed their reply brief on September 2, 2025. *See id.*; Dkt. 211. The Court heard oral argument on September 24, 2025. The Court ordered supplemental briefing, *see* Dkt. 332-2, which the parties filed on January 23, 2026. *See id.*; Dkt. 345, 346, 347.

In light of the status of this related litigation, Plaintiffs request that the stay in this matter should remain in place, and Defendants do not oppose that request.
