**DEFENDANTS' RESPONSE TO INTERVENORS' REQUEST TO EXTEND THE STAY  
ON PARAGRAPH 16 OF THE PROTECTIVE ORDER**

Pursuant to the Court's order dated May 23, 2025, ECF No. 314, Defendants Hartford HealthCare Corporation, Hartford Hospital, Hartford HealthCare Medical Group, and Integrated Care Partners, LLC ("Defendants"), by and through their undersigned attorneys, file this response to the status report submitted by intervenors John Brown, Lisa Fagan, Michael Fagan, Joshua Pawelek, John Stoeck, Advancing CT Together, Estuary Transit District, and Teamsters 671 Health Services & Insurance Plan ("Intervenors") at ECF No. 313.

Defendants take no position on Intervenors' request to extend the stay on paragraph 16 of the operative Protective Order (ECF No. 120) until August 5, 2025. Defendants are not always copied on Intervenors' communications with third parties that produced documents under the Protective Order in this litigation and therefore are not in a position to comment on Plaintiffs' diligence in seeking such materials or need for continuation of the stay.
