Pursuant to the Court's February 8, 2024 Order (ECF No. 211) and April 4,
 2024 Order (ECF No. 214), the parties, by and through their attorneys of record,
 hereby submit this Joint Status Report.

On January 9, 2024, the Court issued an order with its rulings on the parties' 4 5 cross motions for summary judgment (the "Summary Judgment Order"). See ECF No. 207. On February 8, 2024, the Court—at the parties' stipulated request— 6 7 issued an order which (i) confirmed that the Summary Judgment Order was not 8 intended to operate as a final judgment, and (ii) instructed the parties to meet and 9 confer and to file, within 21 days of an order resolving any motion(s) for 10 reconsideration of the Summary Judgment Order, a joint status report regarding the 11 parties' proposed resolution of any outstanding issues for consideration by the Court. See ECF No. 211. On April 4, 2024, the Court issued an order denying 12 13 Defendants' motion for reconsideration, which reiterated that directive to the parties to file a joint status report within 21 days. See ECF No. 214 at 4. 14

15 On April 25, 2024, the parties submitted a joint status which indicated that the parties (i) agree that there do not remain any outstanding issues for 16 17 consideration by the Court, (ii) were in the process of negotiating a proposed Final 18 Judgment, Permanent Injunction, and Stay Pending Appeal, and (iii) would either submit the proposed Final Judgment, Permanent Injunction, and Stay Pending 19 20 Appeal or a further Joint Status Report by May 2, 2024. See ECF No. 215. The 21 parties filed a similar Joint Status Report on May 2, which updated the Court on the parties' progress. See ECF No. 216. 22

The parties have reached agreement on the proposed Final Judgment,
Permanent Injunction, and Stay Pending Appeal, which is attached to this report as
Exhibit A. The parties respectfully request that the Court enter the proposed Final
Judgment, Permanent Injunction, and Stay Pending Appeal.
