The aforementioned motions are resolved as follows:

- (1) The government's motion is granted and this appeal is hereby stayed pending the District Court's resolution of the Commonwealth of Pennsylvania's second motion for a preliminary injunction (Dkt. 90). The Court trusts that the District Court will resolve Pennsylvania's second motion for a preliminary injunction expeditiously;
- (2) No action will be taken on the Commonwealth's motion for remand at this time. Should the District Court indicate an intention to modify or dissolve the current injunction the party's shall follow the procedure set forth in Federal Rule of Civil Procedure 62.1 and Federal Rule of Appellate Procedure 12.1;
- (3) Any appeal arising from Pennsylvania's second motion for a preliminary injunction shall be consolidated with this appeal by the Court Clerk without further order of this Court, *see* Fed. R. App. P. 3(b)(2);
- (4) Within 14 days of the District Court's resolution of Pennsylvania's second motion for a preliminary injunction, the parties shall file a joint status report with this Court setting forth a revised proposed briefing schedule; and
- (5) The motion by the Little Sister of the Poor to set a briefing schedule is denied.
