2 PLEASE TAKE NOTICE that pursuant to the Order on Defendants Cigna Corporation,
3 Cigna Health and Life Insurance Company's ("Defendants") Motion to Dismiss [Dkt. No. 55],
4 Plaintiffs Suzanne Kisting-Leung, Samantha Dababneh, Randall Rentsch, Cristina Thornhill,
5 Amanda Bredlow, and Abdulhussein Abbas ("Plaintiffs") do not intend to file a fourth amended
6 complaint.

7 On March 31, 2025, the Court entered its order granting in part and denying in part
8 Defendants' Motion to Dismiss. The Court noted that since it was the first time ruling on the
9 sufficiency of Plaintiffs' complaint, Plaintiffs will be granted leave to amend. The Court further
10 ordered Plaintiffs to "file either a fourth amended complaint, or a notice of intent not to do so and
11 to only proceed on the claim found to be cognizable in this order" within twenty-one days from
