**ORDER GRANTING JOINT**  
**MOTION TO AMEND SCHEDULING**  
**ORDER**

This matter came before the Court on the Parties Joint Motion to Amend the Pretrial Scheduling Order (Dkt. 209). After careful consideration of the files, records, and proceedings herein, **IT IS HEREBY ORDERED THAT:**

1. The Joint Motion to Amend the Pretrial Scheduling Order is **GRANTED**;
2. The deadline to serve Fed. R. Civ. P. 30(b)(6) deposition notices is **September 28, 2026**.

3. The deadline for Plaintiffs to disclose any expert declaration in support of any class certification motions is reset to **October 14, 2026**.

4. The deadline for Defendants to disclose any expert declarations in opposition to any class certification motions is reset to **January 25, 2027**.

5. The deadline for Plaintiffs' motion for class certification and any *Daubert* motions related to class certification is reset to **February 16, 2027**.

6. The deadline for Defendants' opposition to Plaintiffs' class certification and *Daubert* motions and any opening/opposition *Daubert* motions related to class certification is reset to **April 19, 2027**.

7. The deadline for fact discovery completion is reset to **April 26, 2027**.

8. The deadline for non-dispositive motions related to fact discovery is **May 10, 2027**.

9. The deadline for Plaintiffs' trial expert identities and disclosures is reset to **May 10, 2027**.

10. The deadline for Plaintiffs' reply brief in support of class certification and memorandum in opposition to any of Defendants' *Daubert* motions related to class certification is reset to **May 20, 2027**.

11. The deadline for Defendants' reply briefs in support of any *Daubert* motions related to class certification is reset to **June 21, 2027**.

12. The deadline for Defendants' trial expert identities and disclosures is reset to **August 9, 2027**.

13. The deadline for trial expert discovery completion is reset to **September 13, 2027**.

14. The deadline for all dispositive motions is reset to **September 27, 2027**.

15. The trial ready date is reset to on or about **February 7, 2028**.
