APPELLANTS' UNOPPOSED MOTION FOR VOLUNTARY DISMISSAL <u>OF APPEAL NO. 24-10134.</u>

Pursuant to Federal Rule of Appellate Procedure 42(b) and Eleventh Circuit Rule 42-1(a), Med-Trans Corporation ("Med-Trans Corp.") and REACH Air Medical Services, LLC ("REACH") (collectively, "Plaintiffs-Appellants") hereby move for the voluntary dismissal of Appeal No. 24-10134. In support of this motion, Plaintiffs-Appellants state as follows:

This consolidated appeal arises from Complaints that REACH and Med-Trans Corp. brought against C2C Innovative Solutions, Inc. ("C2C") and insurers Kaiser Foundation Health Plan Inc. ("Kaiser") and Capital Health HMO ("Capital Health"), respectively. Med-Trans Corp. brought claims against Capital Health and C2C in Case No. 3:22-cv-01077. REACH brought claims against Kaiser and C2C in Case No. 3:22-cv-01153. The District Court dismissed both Complaints in a single order. D. Ct. Dkt. No. 65 (Case No. 3:22-cv-01077); D. Ct. Dkt. No. 70 (Case No. 3:22cv-01153). Med-Trans Corp. and REACH both appealed, ECF 1 (No. 24-10134); ECF 1 (No. 24-10135), and this Court granted their unopposed motion to consolidate the two appeals, ECF 15 (No. 24-10134); ECF 20 (No. 24-10135).

Med-Trans Corp. has subsequently resolved its dispute with Capital Health, and thus moves to dismiss Appeal No. 24-10134, including its claims against C2C arising from that dispute. *See* Fed. R. App. P. 42(b) ("An appeal may be dismissed on the appellant's motion on terms agreed to by the parties or fixed by the court.").

Plaintiffs-Appellants *do not* move to dismiss Appeal No. 24-10135, which arises from REACH's claims against Kaiser Health and C2C in Case No. 3:22-cv-01153. REACH's separate claims against C2C and Kaiser in Appeal No. 24-10135 remain live, and Plaintiffs-Appellants intend to timely file their opening brief as to those claims on May 22, 2024.

CONCLUSION

For the foregoing reasons, Plaintiffs-Appellants respectfully request that the Court dismiss Appeal No. 24-10134 arising from Med-Trans Corp.'s claims against Capital Health and C2C.
