Counsel who have appeared pro hac vice in Case No. 2:24-cv-00114-Z-BR may file a Notice of Appearance in the lead case without filing an additional application to appear pro hac vice in the lead case. Counsel who have not appeared in Cause No. 2:24-cv-00114-Z-BR at the point when it is consolidated into the lead case should file a Notice of Appearance only in the lead case.
