JOINT NOTICE AND STATUS REPORT

Plaintiff Association for Accessible Medicines (“AAM”) and Defendant Keith Ellison, the Attorney General of the State of Minnesota, submit the following joint status report in accordance with the Court’s Order Granting Stay of District Court Proceedings Pending Appeal (ECF No. 54).

This Court stayed the above captioned action “until the [Attorney General’s] appeal has been resolved, the Eighth Circuit’s mandate has issued, and the deadline for seeking Supreme Court review has expired.” ECF No. 54. The Eighth Circuit affirmed this Court’s grant of AAM’s motion for preliminary injunction on June 12, 2025. ECF Nos. 56-57. The Eighth Circuit denied the Attorney General’s petition for rehearing en banc on August 1, 2025, and issued the mandate on August 8, 2025. The deadline for seeking Supreme Court review expired on October 30, 2025.

This Court ordered that the parties “jointly notify the Court whether any party has filed a petition for a writ of certiorari.” ECF No. 54. No party petitioned for certiorari.

The parties have preliminarily conferred and expect to be able to present a stipulation to this Court that would resolve all outstanding claims and enable this Court to enter a permanent injunction and final judgment. The parties request two weeks (until November 20, 2025) to present that stipulation or else further update the Court.
