PLAINTIFFS' UNOPPOSED MOTION FOR STATUS HEARING

Pursuant to Magistrate Judge Lambert's Order at D.E. 75, Plaintiffs respectfully request a hearing with the Court regarding current case management and scheduling deadlines. In support of the request, Plaintiffs state as follows:

1. Plaintiffs filed this case on December 23, 2024. D.E. 1.
2. In response, Defendants filed motions to dismiss and to compel arbitration and stay. D.E. 27 & 28. During the pendency of these motions, Defendants also refused to engage in discovery. D.E. 64 & 70.
3. On August 11, 2025, the Court ordered Aetna to file a new pleading to resolve perceived ambiguity as to the temporal scope of Aetna's claims. D.E. 74 & 79.

4. The Court also granted Defendants' motion to stay discovery, in part, pending Plaintiffs' amendment of the complaint and stated that "[i]n the event plaintiffs file an amended complaint, the Court will hold a status hearing regarding current case management and scheduling deadlines." D.E. 75.

5. On October 3, 2025, Plaintiffs filed an amended complaint. D.E. 80.

6. In response, Defendants filed a motion to dismiss and to stay the action. D.E. 84 & 92. Both of those motions are now fully briefed. D.E. 90; 99; 100.

7. In light of Aetna's filing of an amended complaint, and the parties completing briefing related to the motions filed in response thereto, Plaintiffs respectfully request a status hearing with the Court regarding current case management and scheduling deadlines.

CONCLUSION

For the reasons stated, Plaintiffs respectfully request a status hearing with the Court.
