

DECLARATION OF TYLER HAYDELL

- I, Tyler Haydell, declare and state as follows:
- I am a data scientist at Fairmark Partners LLP and have performed work on behalf of Plaintiffs in the above-captioned action. I submit this declaration in opposition to Defendants' Motion to Dismiss.
- 2. Before the Complaint in this case was filed, I navigated to JPMorgan's dedicated Caremark website at https://info.caremark.com/oe/jpmc. That website included a "Your costs" option that allowed users to "Know what you'll pay out-of-pocket for any brand name or generic equivalent prescription drug." By entering the name and dosage of a drug, users could view the "total cost," the amount the "Plan pays" and "Your estimated cost."
 - 3. I searched this website for every drug and dosage for which the Plan's prices are

listed and/or described in the Complaint. The prices in the Complaint accurately reflect my findings.

- 4. I am aware that Defendants' brief in support of their Motion to Dismiss states that "there is every reason to think [Plaintiffs' figures] are not [accurate]" because "the publicly available Plan benefits portal lists a total cost of \$206.59" for a 30-unit prescription of Entecavir (1 mg), rather than the price listed in paragraph 119 of the Complaint, which alleges that Defendant agreed to a price of \$749.30.
- 5. The price in the Complaint accurately reflects the Plan's website at the time I conducted my searches. To protect against potential accusations like Defendants', I saved images of the screenshots of the price details for the drugs and dosages that I searched, including Entecavir (1mg). This is the screenshot I took on August 20, 2024, reflecting a "Total cost" of \$749.30:



6. I have examined the metadata of this image file, which states that the image was created on "Tuesday, August 20, 2024."
