# APPELLANTS' NOTICE REGARDING RESTORING OF APPROPRIATIONS

The defendants-appellants United States, the U.S. Department of Health and Human Services ("HHS") and its subcomponent the Centers for Medicare and Medicaid Services ("CMS"), the Secretary of HHS, and the Administrator of CMS (collectively, "the Government") hereby notify the Court that Department of Justice attorneys have resumed their

usual civil functions as of November 13, 2025. The Government further states as follows:

- 1. At the end of the day on September 30, 2025, the appropriations act that had been funding the Department of Justice expired and appropriations to the Department lapsed.
- 2. On October 8, 2025, the Government moved this Court for a stay of briefing in this case, explaining that Department of Justice attorneys assigned to this appeal were prohibited from working during the lapse of appropriations, except in very limited circumstances. The Government's motion stated that it would notify the Court when the lapse of appropriations ended.
- 3. This Court, by order entered October 16, 2025, granted the Government's "unopposed motion for a stay of briefing and for an extension of time to file [its opening] brief for the total number of days of the lapse in Congressional appropriations." (ECF Doc. 35-2)
- 4. On the evening of November 12, 2025, Congress passed, and President Trump signed, the Continuing Appropriations, Agriculture, Legislative Branch, Military Construction and Veterans Affairs, and

Extensions Act, 2026, H.R. 5371, 119th Cong. (2025), restoring funding to the Department through January 30, 2026.

5. Consistent with the Government's stay motion, undersigned counsel hereby notifies the Court that Congress has appropriated funds for the Department of Justice, allowing the Department of Justice attorneys working on this matter to resume work on November 13, 2025. An extension of 43 days (the length of the lapse in appropriations) from the original due date for the Government's opening brief of October 24, 2025, would fall on December 6, 2025. Because December 6, 2025, is a Saturday, the Government calculates that its opening brief is now due on December 8, 2025. See Fed. R. App. P. 26(a)(1)(C).
