Not all Defendants oppose the Intervening States' intervention. Those that do—the Federal Defendants and Intervening Defendant Little Sisters of the Poor—fail to identify any meaningful reason why the Court should not exercise its discretion and grant permissive intervention. The motion to intervene is timely, this Court is the appropriate venue, and both Rule 24(b)(1) and (b)(2) support intervention here.

I. Intervention is Timely

The timeliness of a motion to intervene focuses on "three primary factors: (1) the stage of the proceeding at which an applicant seeks to intervene; (2) the prejudice to other parties; and (3) the reason for and length of the delay." Order Granting Mot. to Intervene 3, Dkt. No. 274 (quoting *Smith v. L.A. Unified Sch. Dist.*, 830 F.3d 843, 854 (9th Cir. 2016)).

Each set of defendants opposing intervention challenges only one of the three timeliness factors (but not the same one). The Federal Defendants claim that intervention is untimely because "substantive issues have already been dealt with," Dkt. No. 299 at 4 (quotation omitted), but do not address the reason for and length of delay. Little Sisters claims only that the "reason for and length of the delay" in intervening justifies denial of the motion.

The other timeliness factor is "prejudice to other parties." Order Granting M. to Intervene 3, Dkt. No. 274. No party claims that any prejudice or delay will arise from this intervention. Intervening States, like recent Intervenor Oregon, will join in the briefing of Plaintiffs and will not file separate briefs. As this Court recognized in permitting Oregon to intervene, intervention "will promote judicial economy and spare the parties from needing to litigate a similar case in another district." *Id.* at 7 (citations omitted).

A. These Proceedings Are Still in Their Early Stages

The Federal Defendants' timeliness complaints ignore the Court's recent statement that "with respect to the Final Rules, these proceedings are still in their early stages." *Id.* at 3. This motion to intervene is timely because the Intervening States move to intervene before the Final Rules become effective against them and before substantial progress has been made in this case.

The Federal Defendants rely solely on *Acosta v. Huppenthal*, No. CV 10-623 TUC-AWT, 2012 WL 12829994, at *3 (D. Ariz. Feb. 3, 2012), for the proposition that intervention should be

The Ninth Circuit has generally been reluctant to allow intervention when substantive issues have already been dealt with in a case. It is true that the Motion to Intervene was filed more than fourteen months after Plaintiffs' initial Complaint and that it was filed after Defendant's Motion to Dismiss and Plaintiffs' Motion for Preliminary Injunction had been fully briefed and argued before the Court. However, no discovery has taken place and briefing on the parties' summary judgment motions is still ongoing. The Court has yet to deeply engage with the substantive issues at this stage; so far, proceedings have been focused on preliminary matters such as standing. Since the parties have not yet progressed beyond initial matters, the stage of proceedings factor does not weigh against the timeliness of Proposed Intervenors' Motion.

Id. In *Acosta*, parties moved to intervene after more work had been done on the case than has been done here, including motions to dismiss and beginning briefing on summary judgment, a process that will not begin in this case until later this month. Unsurprisingly, *Acosta* permitted intervention under Rule 24(b)(1) after finding the motion timely. *Id.* at *4.

The Federal Defendants provide no basis to revisit this Court's finding in its order granting Oregon's motion to intervene that these proceedings remain "in their early stages."

B. The Reason for and Length of Delay of Intervening States Supports Intervention

Little Sisters, but not the Federal Defendants, asserts intervention is untimely because of the "reason for and length of delay." Dkt. No. 300 at 2. It claims that while Oregon's motion filed earlier this year was timely, this motion is untimely because the Intervening States wrongly looked to the scope of injunction sought by Plaintiffs rather than predicting what injunction the Court ultimately would enter. It also takes issue with the change in Attorneys General in the Intervening States leading to a reevaluation of litigation priorities. Neither complaint supports a conclusion that this motion is untimely.

Little Sisters points to no specific development that has occurred between Oregon's motion and Intervening States' motion that supports an outcome other than intervention here.

Rather, Plaintiffs sought a preliminary injunction with nationwide scope related to the Final Rules on December 19, 2018, Mot. for Prelim. Inj. 25, Dkt. No. 174, and it was not until this Court's order on January 13, 2019, Final Rules Injunction Order at 42–44, Dkt. No. 234, that Intervening States recognized their interests were not adequately protected by the parties here. The Intervening States took the appropriate time to develop the facts to support their case and intervened two months and one day later, before any significant additional work had been done in the case.

The fact that the Attorneys General changed in the Intervening States between when the Amended Complaint was filed challenging the Final Rules and this Court's order granting a preliminary injunction against their enforcement accurately explains why the Intervening States did not join the initial Amended Complaint. But it does not render an otherwise timely intervention untimely. The length of any delay here was minimal and based upon the new Attorneys General ensuring that the facts supported their claims.

C. Intervention Promotes Judicial Economy

As this Court noted in deciding Oregon's motion to intervene, "allowing intervention will promote judicial economy and spare the parties from needing to litigate a similar case in another district." Dkt. No. 274 at 7 (citing *Venegas v. Skaggs*, 867 F.2d 527, 531 (9th Cir. 1989)). Here, the three Intervening States, one of which is in the Ninth Circuit, seek to join a case where the Court is familiar with the issues and has established clear requirements for obtaining injunctive relief. Any other court, be it in Nevada, Michigan, or Colorado, would begin anew and be required to familiarize itself with the lengthy procedural history of the Final Rules. No other lawsuit about the Final Rules has as many state participants as this one and the interests of judicial economy support having a court familiar with the issues address the similar claims brought by the Intervening States.

II. This Court is the Appropriate Venue for Intervening States

The Federal Defendants next claim that allowing intervention will encourage forumshopping. But no Defendant argues venue is improper before this Court. Nor does any Defendant assert that the Intervening States' claims will not be heard by some federal court somewhere,

frustrating judicial economy if a new court has to start from scratch. Like the other states that joined this action to challenge the Final Rules, Intervenor States seek to efficiently address their claims that the Final Rules violate the Administrative Procedure Act and the Constitution.

The Federal Defendants rest their forum-shopping argument on an assertion that the issues in this case have already been decided by other courts against two of the Intervening States and that avoiding those rulings motivates intervention here. This claim is based on a misreading of those cases from Michigan and Colorado. First, this Court recognized that the Defendants' arguments supporting the Final Rules in this case "raise questions that the Supreme Court did not reach in *Hobby Lobby*, *Zubik*, or *Wheaton College*." Order 36, Dkt. No. 234. To the knowledge of Intervening States, no court in any of their jurisdictions has addressed the issues presented in their Complaint. Second, the cases discussed by the Federal Defendants dealt with the question of whether the Religious Freedom Restoration Act allowed the government to require certain organizations to provide certain kinds of contraception. See, e.g., Monaghan v. Sebelius, 931 F. Supp. 2d 794, 808 (E.D. Mich. 2013) (holding that "Plaintiffs have shown that abiding by the mandate will substantially burden their exercise of religion" and that "Plaintiffs have established at least some likelihood of succeeding on the merits for their RFRA claim.") This case, of course, deals with the different question of whether the Federal Government followed the Administrative Procedure Act and U.S. Constitution in changing rules that limit who must provide contraception coverage, and no Plaintiff makes any RFRA claim.

Nor is there any merit to the Federal Defendants' claims that state-by-state intervention is equivalent to nationwide injunctions. Nationwide injunctions in cases brought by states, while sometimes appropriate, sweep all states into the relief regardless of what those non-party states have done. Here, by contrast, only those states that timely intervene, provide sufficiently compelling facts to support intervention, and demonstrate in a separate injunction proceeding their entitlement to relief obtain the benefits of any injunction. *See* Dkt. No. 297 (requiring recent intervenor Oregon to "file a noticed motion that complies with the requirements of Civil Local Rule 7-2" to obtain any preliminary relief).

III. Rule 24(b)(2) Supports Intervention Here

Finally, only the Federal Defendants contend that Rule 24(b)(2), which permits government agencies to intervene when the case concerns a statute they administer, does not permit intervention here. But both parts of its argument—1) that the relevant question focuses on claims or defenses of a *party*, not the proposed intervenor, and 2) that Intervening States do not administer the ACA—reflect a misunderstanding of this case and how the ACA is implemented. First, the state plaintiffs, like the Intervening States, claim that the regulations made under the ACA are invalid, so no relevant distinction about *claims* exists between the Intervening States and current parties. Second, Colorado, Michigan, and Nevada all administer the ACA by regulating health insurance issuers under the ACA, 42 U.S.C. § 300gg-22(a)(1). Under that statute, states "may require that health insurance issuers . . . meet the requirements of this part." *Id*.

Separately, this Court recognized that the Federal Defendants—parties, too—defend the Final Rules by placing "increased emphasis on the availability of contraceptives at Title X family-planning clinics." Order 14, Dkt. No. 234. Colorado, Michigan, and Nevada all administer Title X programs, bringing this case within Rule 24(b)(2)'s requirement that a "party's claim or defense" be "based on" a "statute ... administered by the officer or agency" or "a regulation ... made under the statute." The Federal Defendants justify the Final Rules by pointing to contraception services available under Title X, but those Title X programs are all administered by the Intervening States, as shown in the excerpts of the Title X Family Planning Directory attached as Exhibit A. The Federal Defendants cannot, on the one hand, defend the Final Rules by saying that contraception, though no longer available through an employer, is nonetheless available through Title X programs administered by the states and then, on the other hand, claim that those same states do not administer programs used by the Federal Defendants to defend this lawsuit.

Permissive intervention is appropriate under both Rule 24(b)(1) and (b)(2).

CONCLUSION

Because the Intervening States satisfy both standards for permissive intervention and intervention creates no prejudice, the Intervening States respectfully request that this Court permit them to intervene.


