1 The parties hereby inform the Court that they have executed a settlement agreement (“SA”) and  
2 a related corporate integrity agreement (“CIA”) to resolve all claims in the above matter. Thus, the  
3 parties respectfully ask the Court to vacate all remaining deadlines in the case, including the case  
4 management conference scheduled for September 16, 2021, at 9:30 a.m.

5 Pursuant to the SA, the parties continue to work to resolve the following issues: (i) Relator’s  
6 right under 31 U.S.C. § 3730(d) to reasonable expenses, attorneys’ fees, and costs from the Defendants;  
7 and (ii) Relator’s share of the proceeds of the settlement amount. The parties will notify the Court if  
8 either issue requires further proceedings. Otherwise, once resolved, the parties will file a stipulation  
9 dismissing the action in its entirety under Federal Rule of Civil Procedure 41(a)(1).
