**[Proposed] FINAL JUDGEMENT**

On May 5, 2022, the Court granted in part Defendants’ Motion to Dismiss pursuant to the False Claims Act’s First-to-File Bar, dismissing *United States ex rel. Bicocca v. Permanente Medical Group, Inc.* (Case No. 3:21-cv-03124-EMC) except to the extent it pleads claims based on the California False Claims Act. Dkt. No. 171 at 46. Bicocca’s claims under the California False Claims Act were voluntarily dismissed on February 24, 2022. Dkt. No. 159.

Accordingly, pursuant to the Court’s order dismissing this case in part and the voluntary dismissal of Bicocca’s claims under the California False Claims Act, FINAL JUDGMENT is HEREBY ENTERED against Plaintiff- Relator Bicocca and in favor of Defendants and is without prejudice to the United States.
