ORDER RE TELEPHONIC CONFERENCE

On May 21, 2020, Judge Segal, serving as a Special Master, held a telephonic conference to discuss pending discovery issues with the parties. At the conclusion of the conference, the parties agreed that they would submit a joint report to recommend a six-month extension of all pending dates except the mediation cut-off date. The parties should submit a proposed recommendation for Judge Segal to consider with the joint report and a Word version of the recommendation should be included. The parties should submit the joint report within seven business days of the date of this Order.

The parties also discussed their dispute over Plaintiff's response to Defendants' Interrogatory No. 1 and discussed potential solutions to the dispute. At the end of the conference, it was agreed that Plaintiff would submit a proposal for resolving the dispute over Interrogatory No. 1 by May 28, 2020. Defendants shall submit a proposal for resolving the dispute over Interrogatory No. 1 by June 4, 2020. The Court will consider the proposals and issue a final order by June 11, 2020. If the parties reach an agreement on the proposals, then the parties should submit a stipulation and proposed order to Judge Segal. The parties should submit a Word version of the proposed order.
