**JOINT STIPULATION REGARDING DEADLINE FOR FILING RESPONSIVE
PLEADINGS TO PLAINTIFFS' AMENDED COMPLAINT**

Plaintiffs Wesco, Inc., *et al.* and Defendant Blue Cross Blue Shield of Michigan (“BCBSM”), by and through their attorneys, stipulate and agree as follows:

1. Plaintiffs filed their initial Class Action Complaint in this matter on June 9, 2025 and their First Amended Class Action Complaint on July 28, 2025. Both were filed in the United States District Court for the Eastern District of Michigan.
2. The matter was transferred to this Court on March 25, 2026.
3. On April 1, 2026, BCBSM filed a renewed motion to dismiss Plaintiffs’ First Amended Class Action Complaint.
4. The Court issued an order denying BCBSM’s motion to dismiss on July 29, 2026, establishing August 12, 2026 as the current deadline under Fed. R. Civ. P. 12(a)(4)(A) for BCBSM to file any responsive pleadings.
5. The parties have mutually agreed to extend BCBSM’s deadline for filing responsive pleadings to August 26, 2026.
